Detailed Instructions and Checklist for Completing the Online Letter of Intent

Please see the <u>Call for Applications</u> for all aspects of this funding opportunity other than how to complete the online Letter of Intent. The deadline for LOI submission is **12 noon Pacific, 15 March 2017**. On each page that you complete you will find a "SAVE" button; please click this often. You will be able to return to your work at any time by selecting "Edit" under the "Manage Proposals" tab. All fields can be changed after initially entered.

Before you start: If you don't have a *proposalCENTRAL* account, you will need to create one.

At https://proposalcentral.altum.com, click on "First Time Users" and then click "Register." Please use the pre-loaded profile for your institution (access via "Search Registered Institutions").

Please skip section 4, "Personal Data for Applications," which requests private information that is neither required nor requested by the California HIV/AIDS Research Program. There are no required entries on this page.

Click BOTH BOXES on the bottom of the page to confirm your agreement with their "Terms of Service" and "Acceptable Use Policy," then click the "Register" button. ProposalCENTRAL will send you an email with your username, password and a confirmation number. Once confirmed, return to the system, login, and enter the confirmation number. You won't need that number again.

Log on to proposalCentral and navigate to this Call for Applications.

- 1. Go to proposalCENTRAL and log in.
- 2. Click on the "Grant Opportunities" tab (far right, gray).
- 3. Click on "Filter List by Grantmaker," and select California HIV/AIDS Research Program.
- 4. Find the row for One Step Ahead Initiative 2017, and click on "Apply Now" on the far right.

á	Navigate to Section 1, and Initiate your Submission. Section 1 of the LOI is the title page. Enter the title of your application (not to exceed 60 characters), and click "Save." You have now created a record of your LOI in the system, and you can return to it at any time from the "Manage Proposals" tab. You can continue and complete Section 1 now (see next step), or you can log off and resume work during a later session.
•	Complete the remainder of Section 1. After you have completed Section 1, all other sections may be completed in any order. Project Title: You may edit your title at any time. Requested Award Term: in Years, select one [1,2,3, or 4] Annualized Direct Cost Budget: Total budget divided by award years, must be between \$100,000 and \$750,000 (direct costs only). Now click "save," and then "next."
-	Navigate to Section 2, "Download Templates & Instructions." (Optional) The Call for Applications and the Instructions are posted here for your reference. There is no semplate for this LOI. Click "save," and then "next."
\ 	Complete Section 3, "Enable Other Users to Access This Proposal." You may allow your staff or institutional officials to access this proposal; they must be a registered proposalCentral user. You may elect "view," "edit" (but not submit), or "administrator" (edit and submit) level privileges. Click "save," and then "next."
	Complete Section 4, "Applicant." To change your home institution or any other fields, click on "Edit Professional Profile." When you're done editing your profile, click on "Return to LOI / Proposal." PI Name, Institution, Highest Degree, Position/Title and Academic Rank. Division and Department Address, Email, Phone, Fax. Click "save," and then "next."
 	Complete Section 5, "Institution." It is recommended that you work on this section in advance of the deadline to ensure that it does not interfere with your final submission. The PI's home institution is usually pre-loaded as the Lead institution. To change it, click "Change Institution" and follow the instructions. Otherwise, click "save," and "next."

→ Most research institutions and prior CHRP applicants are in the proposalCENTRAL database. If you have trouble locating yours, try the simplest search term possible (e.g. "Davis") or contact proposalCENTRAL customer service. If your institution is truly not in the database, or if you find multiple profiles for your institution, then your Contracts and Grants office must work with proposalCENTRAL to create a single, new Institution Profile.
